



# Lake Dillon Theatre Company (LDTTC) Youth Workshops Behavior Contract

## Behavioral Guidelines:

LDTTC believes that each student involved in our workshops is entitled to a positive experience. LDTTC wants all students to have fun and do their best. As part of this philosophy, all students are required to follow the behavioral standards:

- Students are expected to be respectful to the Artistic Team, Teachers, LDTTC Staff, parents, other students, and facility representatives.
- Appropriate language must be used at all times. Name-calling, profanity, bullying, and/or inappropriate actions will not be tolerated.
- LDTTC expects students to be respectful of property; therefore, any damage intentionally done to property will be repaired or the damaged elements replaced by the student responsible.
- LDTTC expects purity of self with one's own body; therefore, the use of illegal drugs, alcohol, or tobacco products is strictly prohibited while at a LDTTC activity.
- LDTTC expects students to dress modestly and appropriately, in a way that promotes a healthy environment and eliminates distractions. Overly tight or revealing clothing is not acceptable. Midriffs must be covered. Undergarments are not to be visible or exposed at any time. For student safety, closed-toed shoes must be worn at all times.

## Rehearsal and Performance Guidelines

- Follow all instructions given by Artistic Team, Teachers, LDTTC Staff, parents, other students, and facility representatives.
- Avoid unnecessary noise and distractions during rehearsals and performances.
- Students are expected to stay in approved areas while at a LDTTC facility. LDTTC students should not leave the facilities at any time during rehearsals or performances, unless permission to do so has been given to the LDTTC staff person in charge by the student's parent or guardian. (This includes breaks between classes.)
- Behave in a professional manner at all times during performances and rehearsals.
- All cast and crewmembers must attend all rehearsals and performances unless you are ill or have received the Director of Education's permission.
- Be on time for class, rehearsals, performances and other scheduled activities. (Parents: please pick up your children on time as well.)

## Discipline Procedures (Consequences)

- For the first incident, Director of Education, Staff, and/or individual in charge of a LDTTC activity will talk with the student about his/her misbehavior.
- If misbehavior continues, the Director of Education will call the parent and explain the misbehavior of the student, and the consequences of continued misbehavior.
- If misbehavior continues, the Director of Education will meet with the parent and student to discuss possible dismissal from LDTTC workshops and activities, i.e., class, show, etc.
- Continued misbehavior will result in dismissal from LDTTC activities for the particular session.
- Parents and students should be aware that serious misbehavior will be documented and may effect participation in future LDTTC workshops and activities. In certain cases, misbehavior that LDTTC considers extreme and/or which threatens the well being of others will result in immediate suspension and/or permanent expulsion from all LDTTC workshops and activities.

When registering for LDTTC workshops and classes, camps or other events you must sign and return the attached form stating that you have read and agree to follow the guidelines stated above. Doing so will also signify that you are aware that LDTTC strives to keep students and others safe and free from harm when reasonably possible, but that LDTTC cannot guarantee any person's safety, or that students will comply with these guidelines at all times.
